PRIVACY AND PROTECTION OF PERSONAL INFORMATION POLICY

At The Quebec Drama Federation we strongly believe in the importance of protecting the personal information of our customers, employees and representatives (hereinafter referred to as "you", "your"). We are subject to the Private Sector Privacy Act, and as such, we are committed to maintaining the confidentiality of the personal information we collect in the course of our business (hereinafter referred to as "we", "our").

Our Privacy Policy (the "Policy") is designed to inform you of our practices regarding the collection, use, disclosure and retention of personal information. By choosing to provide us with personal information (whether via our website, customer portal, email, in person or by telephone), you agree to the terms and conditions of this Privacy Policy and authorize us to process your personal information in accordance with it for the purposes set out below.

DEFINITIONS

For the purposes of this Privacy Policy:

- Account means a single account created for you to access our website or parts of it.
- Cookies are small files that are placed on your computer, mobile device or other device by a website, containing details of your browsing history on that website, among its many uses.
- Device means any device a computer, mobile phone or digital tablet that is able to access the Website.
- Personal information or data means any information or intelligence relating to an identified or identifiable individual.
- Service Provider means any natural or legal person who processes this data on behalf of The Quebec Drama Federation. These are third party companies or individuals retained by The Quebec Drama Federation to facilitate the Service, to provide the Service on behalf of The Quebec Drama Federation, to perform services related to the Service or to assist The Quebec Drama Federation in analyzing how the Service is used.
- Third Party Service means any website or social networking site through which a user may log in or create an account to use the Service.
- Usage Data means data collected automatically, whether generated by the use of the website or by the website infrastructure itself (e.g. the length of a visit to a page).

- Website means the website of The Quebec Drama Federation accessible at www.quebecdrama.org
- User means the individual who accesses or uses the Website, or the company or legal entity on whose behalf that individual accesses or uses the Website, as the case may be.
- We may use cookies to collect usage data and improve your experience on our Website.
 We may also use third party services, such as Google Analytics

CONSENT

We are committed to protecting the privacy of our users and only collect and use personal information with their consent and as permitted or required by law.

By using our website located at www.quebecdrama.org, or by providing us with personal information, you agree to the terms of our privacy policy and consent to the collection and use of your personal information in accordance with that policy.

You may withdraw your consent at any time, except where restricted by law or applicable contracts. We will inform you of the consequences of such withdrawal, including the possibility that we may not be able to supply a product or process a request. Please note that your decision to withdraw your consent will be recorded in our records.

In certain circumstances, we may need to collect, use or disclose personal information without your consent. This may occur when legal, medical or security reasons make it impossible or impractical to obtain your consent, or when the information is collected for the investigation of a possible breach of contract, the prevention or detection of fraud, or for law enforcement purposes.

COLLECTION AND USE OF YOUR PERSONAL INFORMATION

When you use our website, we may ask you to provide certain personal information that may be used to contact or identify you. This information may include, but is not limited to:

- Contact information such as name, address, email address and telephone number;
- Biographical information such as job title, employer, photograph and video or audio content;

- Marketing communication preferences and related information, such as feedback and responses to surveys or other information;
- Financial and billing information such as billing address, bank account, credit card number and other payment information;
- Service information, such as details of the services we have provided to you;
- Recruitment information, such as your curriculum vitae, educational and employment background, details of professional affiliations and other information relevant to a potential recruitment or association with The Quebec Drama Federation;
- Usage data may include information such as the IP address of your device, the type of browser you are using, the browser version, the pages of our website you visit, the date and time of your visit, the time spent on those pages, unique device identifiers and other diagnostic data;
- If you access our website via a mobile device, we may automatically collect certain
 information, including the type of mobile device you are using, the unique identifier of
 your mobile device, the IP address of your mobile device, the operating system of your
 mobile device, the type of mobile Internet browser you are using, unique device
 identifiers and other diagnostic data.
- We may also collect information that your browser sends when you visit our website or access our website via a mobile device.
- Any other personal information provided. Please note that if you provide us with personal
 information about other individuals (such as your customers, directors, officers,
 shareholders, employees or beneficial owners), you must ensure that you have given
 those individuals appropriate notice that you are providing their information to us and
 that you have obtained their consent to such disclosure.

WE MAY USE YOUR PERSONAL INFORMATION FOR THE FOLLOWING PURPOSES

The collection, use and disclosure of personal information by The Quebec Drama Federation shall be limited to that which is necessary for the purposes for which it is collected.

The Quebec Drama Federation collects personal information for a variety of reasons, including:

- Responding to your requests;
- Process payments and issue receipts;
- Complete your registration for an event, training, newsletter, annual general meeting, fundraiser, website download or webinar you wish to attend;

- The management of our human resources and service agreements;
- Respect your withdrawal choices;
- To operate, maintain, improve and provide all the features of the website, to provide the services and information requested by you, to respond to comments and queries and to provide assistance to users of the website;
- To provide and improve our website, to understand how users interact with our website
 and to personalize your online experience. In addition, we may use your information to
 manage your account as a user of the website, including to provide you with access to
 various features and to respond to your requests.
- We may also use your information to send you marketing communications or to inform
 you of any important changes to our website or our business. Please note that we will
 not share your information with third parties for marketing purposes unless you expressly
 consent to this;
- To send information, special offers and news about our products, services and events similar to those you have already purchased or have expressed interest in in accordance with applicable laws regarding commercial electronic messages. If you no longer wish to receive such communications, you may unsubscribe at any time by following the instructions provided in our emails or by contacting us directly.

THE ACCURACY OF THE INFORMATION

We will make every effort to ensure that your personal information is as accurate and complete as is necessary for the purposes of its collection, use or disclosure.

USE OF COOKIES AND GOOGLE ANALYTICS

We use tracking technologies such as cookies, tags and scripts to improve and analyze our website. We use temporary and persistent cookies for a variety of reasons, including to provide the services available on the website, to authenticate users, to personalize the user experience and to track information about website traffic and usage.

Some cookies are essential to provide the services requested and to prevent fraudulent use of user accounts. We also use persistent cookies to remember user choices, such as logins and language preferences, to enhance the user experience.

We also use persistent tracking and performance cookies to track website traffic information and to test new pages, features or functionality on the website to observe user reaction. These cookies may be administered by third parties and may directly or indirectly identify you as an individual visitor.

You can set your browser to refuse cookies or to alert you when a cookie is being sent. However, please note that some parts of our website may not function properly if you refuse cookies.

ANALYTICAL DATA

We may use third parties, such as Google Analytics, to help us collect and analyze information about the areas visited on the website in order to evaluate and improve the user experience and the website. These third parties may use cookies and other tracking technologies. CONVERSION PIXELS

Conversion pixels, also known as "clear GIFs" or "spy pixels", are tiny images, usually a single pixel, that can be placed on a web page or in an email to tell us when you have viewed that page or opened that email and to analyze response rates.

RETENTION AND DESTRUCTION OF PERSONAL INFORMATION

We will only retain your personal data for as long as necessary for the purposes set out in this privacy policy. We will retain and use it to the extent necessary to comply with our legal obligations, to resolve disputes and to enforce our legal policies.

We will also retain usage data for internal analysis. This data is generally kept for a shorter period of time, unless it is used to enhance the security or improve the functionality of our website, or we are legally obliged to keep it for longer.

DISCLOSURE OF YOUR PERSONAL INFORMATION

Your data, including your personal data, is processed at our operational offices and at any other location where the parties involved in such processing (such as our service providers) are located. This means that this information may be transferred to computers located outside your state, province, country or other governmental jurisdiction where data protection laws may differ from those in your jurisdiction. As a result, under certain circumstances, foreign governments, courts, law enforcement agencies or regulatory bodies may be permitted to access personal data collected and held under our control.

By using our website, you consent to this transfer. We will take all necessary steps to ensure that your personal data is treated securely and in accordance with this privacy policy. No transfer of your personal data will take place to any organization or country without adequate controls in place, including with regard to the security of your personal data and other personal information.

Each employee, director, volunteer, independent contractor, or ad hoc advisor working on our Board of Directors' committees agrees to respect the personal information we collect. In addition, these individuals undertake to maintain the confidentiality of information specific to our business and not to disclose it or use it for personal gain or for the benefit of others. This commitment exists from the moment the employee, director, volunteer, independent contractor or ad hoc advisor takes up their position and continues indefinitely.

SALE OR TRANSFER OF BUSINESS OR ASSETS

When a business is sold or transferred, your personal data may also be transferred to the purchaser or transferee of the assets. If this happens, The Quebec Drama Federation will require the acquirer to use your personal data in accordance with this privacy policy. This includes the use of your personal data only by the acquirer and its affiliates. If we are involved in a reorganization, dissolution or liquidation, this may also result in your personal data being transferred to a third party. In all cases, we will endeavour to protect your personal data and inform you of any transfers to the extent required by applicable law.

SECURITY OF YOUR PERSONAL INFORMATION

We have put in place appropriate physical, technical and administrative security measures to protect the personal data you provide to us from unauthorized access, use or disclosure. These measures are regularly reviewed and improved to ensure the optimal protection of your data. Although we do our best to protect your personal data, it is important to bear in mind that no method of transmission via the Internet or electronic storage is 100% secure. We therefore cannot guarantee their absolute security.

It is also important to note that we cannot be held responsible for personal data that you share with other users or that you post in public areas such as our blogs. These public areas can be viewed or accessed by anyone visiting our website and are therefore not covered by this policy.

LINKS TO OTHER WEBSITES

Our website may contain links to third party websites. When you follow these links, you leave our website. The information exchanged at that time is no longer subject to our privacy policy. We recommend that you read the privacy statements of other websites you visit before providing any information.

CHILDREN'S PRIVACY

We do not knowingly collect or solicit personal information from children under the age of 13. By using our website, you represent that you are at least 13 years old. If you are under 13, please do not attempt to send us any personal information. If we discover that we have inadvertently collected personal information from a user under the age of 13, we will attempt to delete that information from our files and records immediately. We also encourage website users under the age of 13 to ask their parent or guardian for permission before sending any information about themselves over the Internet.

YOUR RIGHTS

You have the right to know whether we hold personal information about you and to see that

their identity, we will inform the individual whether we hold personal information about them and

disclose that information to them.

We may deny an individual access to his or her information in accordance with applicable law, in

which case we will provide reasons for denying access.
